- (1) Advanced TelCom Group, Inc., respectfully requests approval from the Kentucky Public Service Commission in accordance with 807 KAR 5:001, Section 8, KRS 278.030(2), KRS 278.160, and KRS 278.512, for authority to operate as a reseller and facilities-based provider of interexchange and local exchange telecommunications services. - (4) The names and qualifications of operating personnel and any other evidence to show Applicant has financial, technical, and managerial abilities to provide adequate, reasonable, and efficient service: Attached hereto as Exhibit B are biographies for key management personnel of Advanced TelCom Group, Inc., that demonstrate the technical and managerial abilities to provide adequate, reasonable, and efficient service.
- (5) Attached hereto as Exhibit C is a Proposed interexchange Tariff for Advanced TelCom Group, Inc. A local exchange tariff will be filed upon completion of interconnection negotiations and prior to commencing in accordance with Commission rules.
- (6) Interconnection / Resale Agreement. Advanced TelCom Group, Inc. has not yet entered into Interconnection and/or Resale Agreements with the incumbent local exchange carriers in Kentucky.
- (7) A notarized statement by Richard Levin, Chief Regulatory Counsel for Advanced TelCom Group, Inc., regarding intrastate service is attached hereto as Exhibit D.
- (8) Advanced TelCom Group, Inc., intends to provide interexchange and local exchange telecommunications services to business and residential telecommuter customers.
- (9) Advanced TelCom Group, Inc. will provide telecommunications services utilizing unbundled network elements purchased from the incumbent local exchange carriers and its own facilities. Advanced TelCom Group, Inc. will also provide interexchange and local exchange telecommunications services on a resale basis.
- (10) Advanced TelCom Group, Inc., will comply with the monitoring requirements of the Kentucky Administrative Code 355.
