Re: IDT America, Corp. d/b/a IDT America, Corp. & DSA Telecom

Dear Executive Director Dorman:

By this letter, IDT America, Corp. ("IDT") hereby notifies the Kentucky Public Service Commission that IDT intends to operate under the brand name DSA Telecom. IDT shall offer this service under the brand name DSA Telecom *in addition to* the name IDT, under which the company is authorized to provide resold telecommunications service within the State of Kentucky.¹

IDT is authorized to do business as DSA Telecom pursuant to authorization granted by the Kentucky Secretary of State.² Prior to offering service under the name DSA Telecom, IDT shall file the necessary tariff revisions and will not provide service under the DSA Telecom brand until the effective date of its tariff revisions.


Please be advised that IDT's service offering under the DSA Telecom brand will have no effect on any service offered by IDT within the State of Kentucky: IDT will continue to offer all services presently offered. Furthermore, since DSA Telecom is simply a brand name to be used by IDT and is not a new entity, all existing Kentucky Public Service Commission contact information is identical for IDT and DSA Telecom.


