NOTIFICATION OF TRANSFER OF CONTROL

National Access Long Distance, Inc. ("NALD" or the "Company") hereby files written notice of a proposed transaction ("Transaction") where 100% of the common stock of the Company will be purchased by Martin J. Tibbitts, Individual, 19992 Kelly Road, Harper Woods, MI 48225 ("Buyer") from J. Eric Ross, Individual, 871 Coronado Center Drive, Suite 200, Henderson, NV 89052 ("Seller"). The Transaction will have no effect on the operations of NALD, which remains the holder of its Authority to provide long distance services in Kentucky. As discussed herein, the Transaction will have no impact on Kentucky customers.

I. DESCRIPTION OF THE PARTIES

A. The Company

National Access Long Distance, Inc. is a privately held Nevada Corporation. The Company operates as a long-distance reseller within the state of Kentucky. B. The Seller

The Seller is as follows:

J. Eric Ross is an individual currently residing in the state of Nevada. Currently, Mr. Ross holds 100% of the Common Stock of the Company.

C. The Buyer

The purchaser is as follows:

Martin J. Tibbitts is an individual residing in the state of Michigan. As contemplated within the purchase agreement, Mr. Tibbitts will own 100 % of the Common Stock of the Company.
