RE: Notice of Transfer of Ownership of New Access Communications, LLC from Jasper Holdings LLC to North Central Equity LLC Through a Corporate Reorganization

Dear Mr. Dorman:

Jasper Holdings LLC, a Minnesota limited liability company ("Jasper" or "Seller"), the sole member of New Access Communications, LLC, a Minnesota limited liability company, ("NAC" or the "Company") and North Central Equity LLC, a Minnesota limited liability company, ("North Central" or "Purchaser" and together with Seller the "Parties"), by its attorneys, hereby notifies the Commission of the proposed transfer of ownership of the Company from Jasper to North Central. It is our understanding that under the circumstances set forth below, no formal approval of the Commission is required for this transaction. Accordingly, the Parties will proceed on the understanding that the Commission requires no approval or other formal action with respect to the proposed transaction.

On or about December 16, 2004, North Central and Jasper, entered into an agreement with the Company whereby North Central will acquire 100 percent of the membership interests in the Company. Fifty-three and one half percent of the ultimate individual owners of Jasper own substantially more than a majority of North Central directly; accordingly, there will be no change in control of NAC as a result of this transaction.

The transfer of ownership of the Company from its current member to North Central is in the public interest. The transaction will permit the Company to reorganize current minority interests in an effort to access the financial resources it needs to introduce new products and services and to respond to competition in the telecommunications environment. After the transaction, the Company will continue to operate as it has in the past, using the same name, tariff, and operating authority. North Central intends to retain all key Company personnel, including senior management personnel. Thus, the transfer of ownership will be transparent to, and have no adverse impact upon, the Company's customers. The benefit from increased economies of scale will permit the Company to operate more efficiently and thus to compete more effectively.


