Notice of Transfer of Control

The purpose of this correspondence is to provide notice to the Kentucky Public Service Commission that on October 14, 2010, STi Prepaid, LLC ("STi"), and Vivaro Corporation ("Vivaro") (together with STi the "Parties") consummated an agreement and plan of merger whereby STi merged into Vivaro Acquisition LLC, a wholly-owned subsidiary of Vivaro, with STi remaining as the surviving entity (the "Transaction"). STI is authorized in Kentucky to provide resold long distance telecommunications services pursuant to authorization granted in Docket No. TFS2007-00226 on March 27, 2007.

As a result of the Transaction, Vivaro acquired all membership interests in STi and paid the existing members of STi certain merger consideration in the form of cash. Following the Transaction, STi operates under the control of Vivaro and continues to provide prepaid calling cards services in the State of Kentucky. No changes are planned in the service provided by STi as the result of the transfer of control to Vivaro, and no assignment of STi's assets or customers occurred as a result of the Transaction.
