("PCI") (collectively the "Applicants"), and hereby respectfully request approval for the acquisition of certain assets and for the assignment of an authorization to provide intrastate, long distance telecommunications services within the State of Kentucky, as described herein. In support of this Joint Application, the Applicants hereby state as follows.

I. **DESCRIPTION OF THE APPLICANTS**

PCI, a Florida corporation, is headquartered at 3399 Peachtree Road, NE, \$uite 700, Atlanta, Georgia 30326. PCI is a non-facilities based reseller of post-paid telephone calling card services. PCI is certificated or authorized to provide intrastate, long distance services in Kentucky and in approximately 46 other states.¹
