This Amendment (the "Amendment") amends the Local Wholesale Complete Commercial Agreement (LWC) by and between AT&T-22STATE and Windstream Communications, Inc., Windstream Nuvox, Inc., Windstream Nuvox Arkansas, Inc., Windstream Nuvox Illinois, Inc., Windstream Nuvox Indiana, Inc., Windstream Nuvox Kansas, Inc., Windstream Nuvox Oklahoma, Inc., Windstream Nuvox Missouri, Inc., Windstream Nuvox Ohio, Inc., and Windstream Norlight, Inc. (collectively "WINDSTREAM"), executed July 9, 2009. AT&T-22STATE and WINDSTREAM are hereinafter referred to collectively as the "Parties" and individually as a "Party".

WHEREAS, the Parties acknowledge and agree that the provisions set forth in this Agreement are not subject to and/or required by the Communications Act of 1934, as amended ("Act") including, without limitation, Sections 251/252 of the Telecommunications Act of 1996 and any regulation or rule of the FCC or any state commission, and are not subject to negotiation and/or arbitration under Section 252 of the Act unless both Parties otherwise agree in a writing signed by both Parties.

WHEREAS, the Parties desire to extend the term of the Agreement, modify the pricing, and make certain other changes as set forth below.

WHEREAS, the Parties desire to

NOW, THEREFORE, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

1. Section 8.2.1 of the General Terms and Conditions of the LWC Agreement is hereby amended and restated as follows:
 - 8.2.1 Unless terminated for breach (including nonpayment), the term of this Agreement shall commence upon the Effective Date of this Agreement and shall expire on December 31, 2014 (the "Term"). This Agreement shall automatically terminate on the first day following the Expiration Date of the Term ("Termination Date"), unless both Parties otherwise agree to extend the Term in writing via an amendment to this Agreement. Otherwise, upon the Termination Date of this Agreement, neither Party shall have any further obligation under this Agreement, except as otherwise set forth in this Section 8.0 and pursuant to Survival, Section 38.0 below.
2. Sections 8.6.2, 8.6.3, and 8.6.4 of the General Terms and Conditions of the LWC Agreement are hereby replaced with the following:
 - 8.6.2 Where CARRIER has End Users and/or is purchasing Products and/or Services under this Agreement and either Party seeks to terminate this Agreement, CARRIER shall cooperate in good faith to effect an orderly transition of service under this Agreement. CARRIER shall be solely responsible (from a financial, operational and administrative standpoint) to ensure that its End Users are transitioned to another Carrier or to other AT&T-22STATE wholesale services prior to the Expiration or Termination Date of this Agreement.

- 8.6.3 If at any time within one hundred and eighty (180) days or any time thereafter of the expiration of the Term, if either Party serves "Notice of Expiration", CARRIER shall have ten (10) calendar days to provide AT&T-22STATE written confirmation to the Notice of Expiration indicating if CARRIER wishes to pursue a successor agreement with AT&T-22STATE or terminate its Agreement. If CARRIER wishes to pursue a successor agreement with AT&T-22STATE, CARRIER shall attach to its written confirmation or Notice of Expiration, a written request to commence negotiations with AT&T-22STATE and identify each of the state(s) to which the successor agreement will apply. Upon receipt of CARRIER's request, the Parties may commence good faith negotiations for a successor agreement. If the Parties have not executed a new Agreement within sixty (60) days prior to the Expiration Date of this Agreement (i.e., December 31, 2014), negotiations for a new agreement shall cease unless otherwise mutually agreed to by the Parties, and the Parties shall develop a transition plan to move the services to a different Carrier or to other AT&T-22STATE wholesale services; *provided however*, that the failure to develop a transition plan shall not constitute a breach of this Agreement. In the event the Parties are unable to agree upon a transition plan, AT&T may, at its discretion, disconnect all or any of the services at any time after December 31, 2014.
- 8.6.4 The rates, terms and conditions of this Agreement shall continue in full force and effect until the earlier of: (i) the effective date of the successor agreement, if any; or (ii) the Termination Date set forth in Section 8.2 above. For avoidance of doubt, nothing in this Agreement obligates AT&T-22STATE after the Termination Date to continue to offer or provide any services and/or product that were provided under this Agreement. In the event that services exist after December 31, 2014 (the "Expiration Date"), the rates and terms for such services (for the period from December 31, 2014 until such services are actually transitioned or disconnected) shall be the rates and terms for services in effect as of the Expiration Date, except such rates may be raised or lowered by AT&T upon sixty (60) day's Notice, which Notice shall not be provided before November 1, 2014.
3. Section 44 is hereby added to the General Terms and Conditions of the LWC Agreement as follows:
44. Agreement Implementation in AT&T CALIFORNIA and AT&T NEVADA
- 44.1 In AT&T WEST REGION 2-STATE or AT&T CALIFORNIA and AT&T NEVADA, AT&T requires up to a **twelve (12)** month period to load LWC rates. If CARRIER is a new entrant into AT&T WEST REGION 2-STATE and has never ordered in this region before, CARRIER will not be able to order LWC in AT&T WEST REGION 2-STATE until such LWC rates are loaded. If CARRIER has had previous rates loaded in AT&T WEST REGION 2-STATE and this contract or amendment amends such rates, then the new rates will be applied retroactively to the effective date of this contract or amendment, and CARRIER's LWC ordering ability will not be impacted. The back-billing limitation in section 12.10.1.1 of the General Terms and Conditions shall not apply to any retroactive billing adjustment that may apply as a result of this section.
4. LDMI Telecommunications, Inc. ("LDMI") is added as a Party to the Agreement.
5. For LDMI, the Agreement will be applicable in the states of Michigan, Ohio and Wisconsin.
6. McLeodUSA Telecommunications Services L.L.C in the states of Arkansas, Indiana, Michigan, Oklahoma, and Wisconsin; McLeodUSA Telecommunications Services, LLC in the states of Kansas and Ohio; McLeodUSA Telecommunications Services, L.L.C d/b/a Cavalier d/b/a PAETEC Business Services in the states of Illinois and Texas; and McLeodUSA Telecommunications Services, Inc. in the state of Missouri; (collectively referred to as "McLeodUSA") are added as Parties to the Agreement.


7. For McLeodUSA, the Agreement will be applicable in the states of Arkansas, Illinois, Indiana, Kansas, Michigan, Missouri, Ohio, Oklahoma, Texas and Wisconsin.
8. Network Telephone Corporation in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, North Carolina, South Carolina and Tennessee; and Network Telephone Corporation d/b/a PAETEC Business Services in the state of Mississippi (collectively referred to as "Network Tel") are added as Parties to the Agreement.
9. For Network Tel, the Agreement will be applicable in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
10. PAETEC COMMUNICATIONS, INC. in the states of California, Connecticut, Florida, Georgia, Illinois, Michigan, North Carolina, Ohio and Texas, (collectively referred to as "PaeTec") is added as a Party to the Agreement.
11. For PaeTec, the Agreement will be applicable in the states of California, Connecticut, Florida, Georgia, Illinois, Michigan, North Carolina, Ohio and Texas.
12. Talk America, Inc, in the states of Alabama, Florida, Georgia, North Carolina; TALK AMERICA, INC. in Kentucky Louisiana, South Carolina and Tennessee; and TALK AMERICA, INC d/b/a PAETEC Business Services in Mississippi; (collectively referred to as "Talk") are added as Parties to the Agreement.
13. For Talk, the Agreement will be applicable in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
14. The Other Phone Company, Inc. in the state of Alabama; THE OTHER PHONE COMPANY, INC. in the states of Florida, Kentucky, Louisiana, North Carolina, South Carolina and Tennessee; and THE OTHER PHONE COMPANY, Inc. d/b/a PAETEC Business Services in the state of Mississippi, (collectively referred to as "The Other Phone Company") are added as Parties to the Agreement.
15. For The Other Phone Company, the Agreement will be applicable in the states of Alabama, Florida, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.
16. US LEC of Alabama, LLC in the state of Alabama, US LEC of Georgia, LLC in the state of Georgia and US LEC of South Carolina, LLC in the state of South Carolina, (collectively referred to as "US LEC") are added as Parties to the Agreement
17. For US LEC, the Agreement will be applicable in the states of Alabama, Georgia and South Carolina.
18. Upon execution of this Amendment, the LWC Agreement between BellSouth Telecommunications, LLC d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina and AT&T Tennessee; Southwestern Bell Telephone Company d/b/a AT&T Arkansas, AT&T Kansas, AT&T Missouri, AT&T Oklahoma, and AT&T Texas; Illinois Bell Telephone Company d/b/a AT&T Illinois; Indiana Bell Telephone Company Incorporated d/b/a AT&T Indiana; Michigan Bell Telephone Company d/b/a AT&T Michigan; The Ohio Bell Telephone Company d/b/a AT&T Ohio; Wisconsin Bell, Inc. d/b/a AT&T Wisconsin; Pacific Bell Telephone Company d/b/a AT&T California; and The Southern New England Telephone Company d/b/a AT&T Connecticut and PAETEC Communications, Inc., LDMI Telecommunications, Inc. McLeodUSA Telecommunications Services LLC; McLeodUSA Telecommunications Services, L.L.C. d/b/a PAETEC Business Services; McLeodUSA Telecommunications Services, L.L.C.; Network Telephone Corporation; Network Telephone Corporation d/b/a PAETEC Business Services; PAETEC COMMUNICATIONS, INC; Talk America, Inc; TALK AMERICA, INC.; TALK AMERICA, INC. d/b/a PAETEC Business Services; The Other Phone Company, Inc.; THE OTHER PHONE COMPANY, INC.; THE OTHER PHONE COMPANY, INC.


d/b/a PAETEC Business Services; ; US LEC of Alabama, LLC; US LEC of Georgia, LLC and US LEC of South Carolina, LLC shall be terminated.

19. The Parties agree to amend the Agreement's Pricing Schedule for the LWC Business Class of Service rates and Service Order Expedite rates as set forth in Attachment A attached hereto.
20. The Parties shall sign this Amendment prior to April 30, 2012. This new rate structure shall include retroactive true-up of the Business Class of Service rates in Attachment A back to January 1, 2012, including proration of such rates on any LWC lines that were added, changed or disconnected during the period from January 1, 2012 and April 30, 2012.
21. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
22. AT&T-22STATE will file a copy of the fully executed Amendment with the FCC under 47 U.S.C. § 211.
23. The Effective Date of this Amendment shall be January 1, 2012 (the "Effective Date").

BellSouth Telecommunications, LLC d/b/a AT&T Alabama, AT&T Florida, AT&T Georgia, AT&T Kentucky, AT&T Louisiana, AT&T Mississippi, AT&T North Carolina, AT&T South Carolina and AT&T Tennessee; Illinois Bell Telephone Company d/b/a AT&T Illinois, Indiana Bell Telephone Company Incorporated d/b/a AT&T Indiana, Michigan Bell Telephone Company d/b/a AT&T Michigan, The Ohio Bell Telephone Company d/b/a AT&T Ohio, Pacific Bell Telephone Company d/b/a AT&T California, The Southern New England Telephone Company d/b/a AT&T Connecticut, Southwestern Bell Telephone Company d/b/a AT&T Arkansas, AT&T Kansas, AT&T Missouri, AT&T Oklahoma, AT&T Texas, and Wisconsin Bell, Inc. d/b/a AT&T Wisconsin by AT&T Services, Inc., its authorized agent
